

## Stellar Driving School Terms and Conditions

- I consent to the release of any information contained in registration form to the Ministry of Transportation, Insurance Bureau of Canada and the MTO Course Inspector.
- Basic computer literacy is a must in order to pass this online course.
- An In-Car lesson cancelled within 24 Hrs is subject to a \$40 cancellation fee.
- By registering and submitting your entry for Digital BDE you acknowledge that you and your parents/guardian (for those under 18 years) agree to policy.
- You can ask for full fee refund within 45 minutes of lessons of digital BDE (\$50 administration fee will apply). \$100 Deduction if you have gone beyond 45 minutes. No refund after start of in car lessons.
- There will be a charge of \$50 if a Cheque is returned (NSF).
- Driving Instructor may assist and / or direct the student verbally and take control of the vehicle physically to steer and / or stop the vehicle in a dangerous or unsafe situation.
- Road test fees included in all packages are for a local road test. Out of town road tests are subject to an extra fee depending on the location of the test center.
- All training activity may be photographed and recorded for training and marketing purposes.
- Pick and drop from home or close vicinity is based on the student's home address on their license or otherwise agreed upon in written prior to the registration. It is students or parent/guardian's responsibility that student arrives at the agreed upon location for lesson pickup.
- In-Car lessons will always end back at the pickup location unless written prior arrangements have been made with the Driving instructor.
- In-Car lessons will start after the completion of online portion of the BDE course
- It is student's responsibility to make sure that all parts of the BDE course are completed within one year from the date of registration.
- It is student's responsibility to inform In-Car instructor on the first lesson about the time remaining to complete the course and arrange the In-Car lessons to be completed within one year of registration.

- Training will be discontinued without refund for any disruptive or dangerous behaviour or for not adhering to Ministry of Transportation or school policies.
- Once a student is certified upon the course completion, they will have to obtain the proof of certification from service Ontario by requesting their Drivers License History.
- If an In-Car instructor finds a student impaired, emotional or in a medical condition his / her driving lesson may be cancelled.
